## **Secretary of State Kevin Shelley Releases List of Presidential Candidates for March 2004 Primary Election**

SACRAMENTO—Secretary of State Kevin Shelley released today the list of generally recognized candidates who will appear on the March 2, 2004, presidential primary ballot.

The major party candidates selected by Secretary Shelley are those who are “generally recognized” throughout the United States or California as candidates actively seeking their respective party nominations. In addition, all qualified political parties in California are asked to submit a list of candidates whom they recognize as seeking their party’s nomination.

Secretary Shelley has the option to place additional names on the ballot until December 25, 2003, when he officially certifies the presidential list. He is not allowed to remove any names from the ballot once they have been announced. However, if today’s selected candidates desire to have their names withdrawn from California’s primary election ballot, they must file an affidavit requesting their names be removed with the Secretary of State’s office.

A complete listing of the candidates approved by Secretary Shelley is attached.
