## Introduction

### California Secretary of State Students Vote Project

Established in 2016, the [\*\*California Secretary of State \(SOS\) Students Vote Project \(SVP\)\*\*](#) is a statewide nonpartisan program that amplifies college student voices and promotes civic engagement efforts to build a more inclusive democracy. Through the creation of the Students Vote Project, California was the first state in the nation to form partnerships across the state's major higher education systems to empower students to participate in the democratic process. The program objectives aim to improve college student voter education, increase college student voter registration, and provide civic and voter outreach opportunities. The SVP achieves these objectives by hosting civic engagement events, creating educational resources, and partnering with campuses and outreach organizations.

One civic engagement event that occurs during statewide election years is the [\*\*California College and University Ballot Bowl\*\*](#). The Ballot Bowl is a friendly competition in which higher education campuses compete to register the most students to vote and showcase civic engagement efforts. The SVP hosts the Ballot Bowl during an even numbered years leading up to the general election.

### The Student Civic and Voter Empowerment Act

In 2019, the Student Civic and Voter Empowerment Act (SCVEA) ([\*\*California Education Code §§ 66850-66852; California Elections Code § 2148.5\*\*](#)) was enacted to provide California colleges and universities with the necessary tools to enhance civic engagement and participation among young voters. In 2020, the California Secretary of State Students Vote Project was expanded to support implementation of the landmark law. The law requires the California SOS to collaborate with the California Community Colleges (CCCs) and California State Universities (CSUs) to increase college student voter registration. Colleges and universities are encouraged to participate in SVP civic learning opportunities to receive and distribute voter education resources. While the University of California (UC) and the Association of Independent California Colleges and Universities (AICCU) campuses are not required to participate, they continue to be strong partners and supporters of student civic engagement.

## 2025 College Student Voter Registration

This section outlines the strategy utilized to track college student voter registration in California. In accordance with the Student Civic and Voter Empowerment Act (SCVEA) ([California Education Code §§ 66850-66852](#); [California Elections Code § 2148.5](#)), we are required to track and report on college student voter registration. This section provides comparative data on college student voter registration from both the current and previous year.

### Tracking Methods

The methods to track registration include online voter registration using the [college student voter registration link](#) and paper voter registration cards. Below is a detailed description of each tracking method used by the California SOS.

#### Online Voter Registration

Online college student voter registration by campus is tracked through the link ([registertovote.ca.gov/collegestudents](#)). This link allows the California SOS to track college student voter registrations by individual campuses.

#### Paper Voter Registration

Paper voter registration cards (VRCs) can be requested from the California Secretary of State's office by campuses. When requesting VRCs, campuses should make a note on the [Voter Registration Card Statement of Distribution form](#) that the cards will be used for college students and to include the campus name.

To submit a request for paper voter registration cards, campuses must email the completed Voter Registration Card Statement of Distribution Form(s) to [vrc-vnc@sos.ca.gov](mailto:vrc-vnc@sos.ca.gov) and [caststudentsvote@sos.ca.gov](mailto:caststudentsvote@sos.ca.gov).

If a campus has any questions about requesting paper voter registration cards, they can contact [vrc-vnc@sos.ca.gov](mailto:vrc-vnc@sos.ca.gov) and copy [caststudentsvote@sos.ca.gov](mailto:caststudentsvote@sos.ca.gov).

*If a campus receives paper VRCs from their local County Elections Office or County Registrar of Voters, they can contact the respective county to request the affidavit number range. Once the affidavit number range is received from the county, it should email the number range to [caststudentsvote@sos.ca.gov](mailto:caststudentsvote@sos.ca.gov).*

When comparing 2024 to 2025, we observed a notable decline in both online and overall college student voter registrations. This trend in decline aligns with our program's ongoing observation that voter registration activity typically decreases during non-election years. While we aim to reduce the disparity through continued outreach and engagement, we also recognize that the perceived urgency to update voter registration information is often lower outside of known election cycles.

## Students Vote Project Programming

Through innovative programs, resources, and partnerships, SVP is equipping campuses with the tools needed to strengthen voter education, registration, and participation. The following section highlights SVP's recent civic engagement resources, new and ongoing projects, and collaborative efforts with educational institutions and statewide partners.

### Civic Engagement Resources

The resources below were developed to support California colleges and universities in strengthening ongoing student civic engagement.

- **2025 Statewide Special Election College Student Voter Resource Guide**: This resource guide provided key dates and election information, sample social media graphics and email language for California Colleges and Universities for the November 4, 2025, Statewide Special Election.
- **2025-2026 California Civic and Election Dates Calendar**: The calendar outlines key civic and election dates for the 2025-2026 academic year. This resource is accompanied by sample email language that campuses can use to communicate with their student body.
- **Video: How to Navigate the College Student Voter Registration Link**: This short video shows California college and university students how to navigate to the college student voter registration link and how to select a campus from the dropdown menu.
- **College Hub**: The website formerly known as **caballotbowl.sos.ca.gov** is now **collegehub.sos.ca.gov**. This change reflects the site's expanded role beyond the Ballot Bowl, serving as the central platform for all SVP competitions and annual college student voter registration tracking. The new name and identity better represent its function as a comprehensive hub for college student civic engagement data and resources. In addition to the name change, the SVP team collaborated with the Information Technology Division with the goal of aligning College Hub with the California Secretary of State's main website design.

## California University and College Ballot Bowl Award Ceremonies


The California University and College Ballot Bowl is a competition where California colleges and universities compete to register the most students to vote and showcase civic engagement efforts. The SVP honored the champion and winning campuses.

- **In-Person Champion Awards Ceremony:** UC Santa Barbara was the 2024 California University and College Ballot Bowl Champion. In a show of appreciation for their outstanding civic engagement efforts, California Secretary of State, Shirley N. Weber, Ph.D., the SVP team, and Secretary of State staff traveled to UCSB to honor students and faculty. Students were recognized for their efforts in voter registration, achieving a high percentage of registered students, and submitting a strong Civic and Voter Empowerment Action Plan.



Shirley N. Weber, Ph.D., California Secretary of State presented the Ballot Bowl trophy to UC Santa Barbara staff and students.

- **Virtual Awards Ceremony:** The 2025 Virtual Awards Ceremony recognized the winners of the 2024 California University and College Ballot Bowl. Shirley N. Weber, Ph.D., California Secretary of State presented a total of 13 awards to a representative from each winning campus.

## Leadership Engagement

Throughout 2025, Shirley N. Weber, Ph.D., California Secretary of State, continued her strong commitment to engaging California's colleges and universities by participating in a wide range of campus events across the four higher education systems. Secretary Weber's participation and engagement included keynote remarks, panel discussions, leadership lectures, and student-centered dialogues at 16 California higher education campuses. Across these visits, Secretary Weber highlighted themes central to her public service, including civic engagement, representation, governance, education, and the power of student leadership. In turn, this further strengthened partnerships with campus administrators, faculty, and student organizations. Her presence at cultural celebrations, leadership conferences, academic panels, and Ballot Bowl-related events reinforced the agency's commitment to empowering young voters and elevating civic participation statewide.

## Office Hours

Office Hours is a designated time when the SVP team is available to provide support, guidance, and resources. Office Hours demonstrates our commitment to engage with

colleges, universities, college students, and organizations by dedicating time each week to guarantee availability. Although these times are set on a recurring basis, our program is flexible to meet outside of the designated timeframe.

### **Quarterly Meeting**

This year SVP only hosted one quarterly meeting in February. We reached 76 registrants and virtual attendees. The fruitful meeting included topics such as 2024 highlights and 2025 program goals and resources. Between the first and second quarters of the year, we worked on programming and resources for 2026. During quarters three and four, SVP focused on outreach and education resources for the Statewide Special Election.

### **State of Engagement Summit**

In the fall, SVP attended the State of Engagement Summit. This event was co-hosted and co-designed by the [\*\*UC Berkeley Possibility Lab\*\*](#), in partnership with the Governor's Office and the State of Engagement Planning Committee. The in-person summit highlighted innovative and impactful practices in civic and community engagement across California's state government. Alongside nearly 100 state

practitioners, SVP learned from and connected with agencies conducting similar work, identifying opportunities for collaboration and shared learning moving forward.

The UC Berkeley Possibility Lab also released a new report examining how California state agencies and departments are engaging with residents from diverse communities. The report features the Students Vote Project as one of several initiatives selected through a statewide nomination process for its exemplary approach to civic engagement. Published in the [\*\*CalMatters Knowledge Hub\*\*](#) as part of the Possibility Lab's research partnership, the report highlights innovative strategies that strengthen community connection and trust in government. ### **Students Vote Project Survey**

The SVP team sent an electronic survey to college campus civic coordinators and leaders to gauge their interest in participating in a new civic engagement performance measure. The survey contained questions regarding the possible incorporation of a commitment to voting with the goal of including it into future SVP programming. Feedback was overwhelmingly positive with most in favor of including a new performance measure.

### **NASPA Civic Learning and Social Change Conference**

The California Secretary of State office attended the NASPA Civic Learning and Social Change Conference in Long Beach, California. Shirley, N, Weber, Ph.D, California Secretary of State was invited to be a keynote speaker for the conference delivering inspiring remarks to college students and staff. The California Secretary of State Students Vote Project team participated on the panel *Campus Civic Engagement Reimagined: What the Student Voter Empowerment Act Model Offers to Higher Ed* where we shared our experience implementing the SCVEA in California.

## **Civic Engagement Projects**

### **Ongoing Projects**

#### **California University and College Ballot Bowl Updates**

SVP is continuing to improve the Ballot Bowl competition to recognize campuses who champion civic engagement. Updates are still being implemented at the time of this report, and the program expects to have the updated competition ready for the 2026 General Election.

#### **Civic and Voter Empowerment Action Plan Guidelines and Evaluation Rubric:**

This resource will serve as a guide for creating and evaluating a Civic and Voter Empowerment Action Plan (CVEAP). A CVEAP is a document developed by California colleges and universities that includes civic engagement initiatives and strategies a campus intends to implement over two academic years. This guide will contain all

essential components needed to draft a successful action plan based on the California Secretary of State expectations.

## Upcoming Projects

### **California College and University Engage the Vote Championship**

SVP is preparing to launch an exciting new initiative ahead of the 2026 Primary Election season. The Engage the Vote Championship is a 10-week, statewide tournament designed to increase college student engagement and voter participation prior the primary election. Throughout the tournament, campuses across California will compete to achieve the highest combined percentage of students who register to vote and make a plan to vote. This friendly tournament encourages students to go beyond registration by taking concrete steps to participate in the election.

### **Make a Plan to Vote Tool**

The Make a Plan to Vote Tool is an online form where California college and university students can complete to make a plan to vote in an election year. The form is currently in development, with an anticipated launch of the Engage the Vote competition in March 2026. The SVP is hopeful that this new resource will empower college students to become more informed and proactive voters in future elections.

## **Students Vote Project Assessment and Reflection**

This section assesses and reflects on key programs and projects. It also draws an analysis of the Student Civic and Voter Empowerment Act (SCVEA) implementation, emphasizing the roles of the Civic and Voter Empowerment Coordinators (CVECs). SVP's programming integrates voter registration tracking, resource development, and campus partnerships to ensure that students across all segments of higher education are informed, registered, and ready to participate in the election process.

## **Program Assessment**

### **1. Strengthening Statewide Civic Infrastructure**

The redesign of College Hub modernized how student civic engagement data is collected and communicated. This website currently serves as a space to show college student voter registration data and will be expanded to display other civic engagement efforts. This transition moves the program toward providing campuses with consistent and reliable metrics to help guide their progress and outreach strategies.

### **2. Broadening Collaborative Partnerships**

This year's efforts showed notable growth in interagency collaboration. Participation in the State of Engagement Summit demonstrate SVP's

expanding role in statewide civic engagement spaces, with its inclusion in the UC Berkeley Possibility Lab report supporting these efforts.

### 3. **Expanding Beyond Voter Registration**

SVP is shifting from a “voter registration-only” approach to a more civic-focused strategy. With the pending launch of the Engage the Vote Championship and Make a Plan to Vote Tool, these new additions aim to help encourage campuses to support college student voter education and participation. These expanded efforts align SVP with national best practices and responds directly to campus feedback calling for more “action-oriented” programming.

### 4. **Statewide Visibility Through Leadership Engagement**

Secretary Weber’s campus visits helped increase visibility of the SVP program. Her contribution in campus events emphasized the importance student civic engagement and the shared responsibility to be active participants in California’s democratic infrastructure.

## **The Student Civic and Voter Empowerment Act Implementation Assessment**

The following section provides a comprehensive overview of how the California Secretary of State implements the Student Civic and Voter Empowerment Act (SCVEA). This section explores key components of SCVEA including the role(s) of the Civic and Voter Empowerment Coordinators (CVECs).

### **The SCVEA Implementation Guide**

To promote understanding and accessibility of the SCVEA’s requirements, the Students Vote Project (SVP) developed the [\*\*Student Civic and Voter Empowerment Act Implementation Guide\*\*](#) in 2023. This resource was designed to reach a broader audience, clarify statutory expectations, and support campuses in meeting their legal obligations under the Act. This year, the essential implementation guide was shared with several new CVECs to help them better understand their role. This resource will continue to be promoted in future SVP programming.

### **Civic and Voter Empowerment Coordinators (CVECs)**

The SCVEA states that all California State Universities and California Community Colleges must identify an individual on campus to be a CVEC. The CVEC is responsible for ensuring the duties outlined in the SCVEA are implemented on their campus.

CVECs include, but are not limited to:

- Government Relations Directors/Assistants
- Student Life Directors
- Professors
- University/College staff that work closely with students

The SVP maintains and updates a statewide database of CVEC contacts to facilitate direct communication, share resources, and ensure consistent program support across all campuses. Below is a table which shows the current number of CVECs confirmed per higher education system in 2025 compared to previous years.

As of December 2025, the Students Vote Project has maintained strong statewide engagement in the implementation of the SCVEA. The California Community Colleges (CCC) system demonstrated significant progress between 2022 and 2024, achieving 100% participation in 2024, before a **slight decrease** in 2025 (approximately 98%).

The California State University (CSU) and University of California (UC) systems both maintained 100% CVEC confirmation from 2022 through 2024 and 2025.

The most notable CVEC increase occurred within the Association of Independent California Colleges and Universities (AICCU) system. AICCU CVEC confirmation increased steadily from 17% in 2022 to 35% in 2025.

The statewide total of identified CVECs rose substantially from 119 in 2022 to 177 in 2025, underscoring the SVP's success in expanding its network of civic engagement leaders. These efforts illustrate the program's ongoing commitment to ensuring all California higher education students have equitable access to civic learning opportunities, voter education, and engagement resources.

## Reflection

Overall, the California Secretary of State's Students Vote Project remains a foundation of college student civic engagement in the state. By modernizing online voter tools, creating educational resources, and being active participants in campus events, we continue to empower college students and campuses to take an active role in our democracy. The program's ongoing commitment to accessibility, transparency, and collaboration positions us for continued growth leading into the 2026 election cycle. The SVP will continue to collaborate with higher education partners and explore opportunities to coordinate with other state agencies engaged in public participation and civic empowerment work. These partnerships will help ensure the continued success of the SCVEA implementation.

## Program Goals

Below is a review of the 2025 SVP program goals and how they were accomplished. Also included is an outline of 2026 program goals.

### 2025 Goals

Through meeting with college representatives and students, participation in campus events, and feedback from higher education partners, all 2025 goals were successfully accomplished. This accomplishment underscores the collective dedication and effort by the California Secretary of State Students Vote Project team.

#### 1. Increase Civic Engagement on College Campuses

- Maintained active engagement with 177 CVECs statewide across the CCC, CSU, UC, and AICCU systems.
- Hosted and participated in statewide events, including:
  - Ballot Bowl In-Person and Virtual Award Ceremonies
  - Campus visits by leadership
  - One Quarterly Meeting

- o State of Engagement Summit
- o Civic Learning and Social Change Conference

## **2. Develop Educational Resources**

Each resource was distributed to campus civic coordinators and partners for statewide implementation.

## **3. Continue to Increase Collaboration Between SVP, Campuses, Stakeholders, and Other Partners**

In 2025, SVP conducted direct engagement with at least nine colleges and universities and nine statewide and national organizations through Office Hours, meetings, and collaborative projects. Our participation in the State of Engagement Summit and recognition in the UC Berkeley Possibility Lab statewide report further demonstrate partner collaboration.

## **4. Improve the California University and College Ballot Bowl Competition**

Updates are still being developed at the time of this report. In 2025, the SVP team worked on updating rules, criteria, and toolkit for future Ballot Bowl competitions.

## **2026 Goals**

### **1. Strengthen Interagency Collaboration**

- We would like to expand partnerships not only across California's four higher education systems, but also with other state agencies that work on civic and community engagement activities.

### **2. Launch the Engage the Vote and Ballot Bowl Competitions**

- Launch a new civic competition, Engage the Vote Championship, prior to the 2026 Primary Election. We also plan to launch the updated California University and College Ballot Bowl competition leading up to the general election.

### **3. Increase Accessibility and Inclusive Engagement**

- Develop inclusive civic engagement programming for underrepresented and hard-to-reach college student populations.

#### 4. Share the Importance of Early Voting in the 2026 Election Cycle

- Create messaging and graphics to heavily push early voting and registration information prior to the voter registration deadline.

## Conclusion

The California Secretary of State Students Vote Project (SVP) continued to build momentum in 2025, advancing our mission to strengthen civic engagement across California's colleges and universities. The year began with the celebration of the California University and College Ballot Bowl winners and recognizing outstanding efforts in college student voter registration and participation.

In 2025, our program focused on refining civic engagement competitions to better connect with students and emphasize the importance of participating in both primary and general elections. This aligns with the anticipated launch of the Engage the Vote competition and the Make a Plan to Vote online tool.

SVP continued to support Civic and Voter Empowerment Coordinators (CVECs) and campus partners through regular communication, resource development, and direct engagement. These efforts helped foster a stronger culture of civic participation across all four California higher education systems and civic engagement organizations.

In addition, the program gathered valuable feedback from campuses regarding challenges students faced during recent elections. SVP is using this valuable insight to proactively address these issues in future election cycles. We hope to help create a seamless and more accessible voting experience for college student voters.

Looking ahead to 2026, SVP will focus on deepening partnerships, expanding outreach to underrepresented student populations, and streamlining access to civic resources. With the strong foundation built in 2025, the program is well positioned to continue empowering students to engage in California's democratic process. We will work to continue to lead the way in college student civic engagement statewide and beyond.
